
Emissions Reduction Targets

In order to progress to achieving Net Zero by 2050, we have adopted the following carbon reduction targets.

It is the Company's intention to reduce emissions by 5% per capita per annum.

We project that carbon emissions will decrease over the next five years to 2.45 tCO2e per capita by 2028. This is a reduction of 22.62%.

Carbon Reduction Projects

In 2023, the following environmental management measures and projects were implemented since the 2022 baseline.

- Continue with ISO:14001 Accreditation and follow our comprehensive Environmental Management System;
- Set up of the Motion Climate Change Group to drive the carbon-reduction programme;
- Implementation of Green Champions in each Motion office will help to ensure best practice on the ground and encourage switches in behaviour;
- Electric Vehicle Salary Sacrifice Scheme set up in partnership with Octopus Energy;
- > Introduction of annual Motion Green Week to educate staff on sustainable living / travel.

In 2024, we have identified the following carbon reduction measures:

- Continue with ISO:14001 Accreditation and follow our comprehensive Environmental Management System;
- Work with our landlords to secure future electricity supplies to our offices that are from verified renewable energy sources and promoting building modifications where possible to facilitate onsite generation;
- Encourage more staff to take advantage of the Electric Vehicle Salary Sacrifice Scheme that we run in partnership with Octopus Energy;
- Further promote the cycle to work scheme that we offer;
- Hold our second annual Green Week to promote other sustainable travel behaviours and educate staff with a CPD in sustainability and the reduction of individuals carbon footprint;
- Move towards a fully paperless office;
- Minimise waste and recycle;
- Work with procurement to order items with less deliveries. Avoid ordering items that can be bought from the local supermarket.

Carbon Offsetting / Avoidance Projects

Since 2023, we have working closely with Ecologi on a number of carbon avoidance projects:

- We plant one tree for each client project instruction as part of a regular initiative. This will make a positive difference to the country's tree ecology and biodiversity. As of April 2024, we have planted 1,297 trees;
- > We are offsetting emissions by supporting global avoidance projects.
